AN ORDINANCE TO AMEND THE  
ROAD USE/MOTOR VEHICLE CONTROL ORDINANCE #05-102 AND  
APPEAL ORDINANCE #09-102**

The Town Board of the Town of Rice Lake do ordain to amend the Code of Ordinances by appealing Ordinance #09-102 and replacing section 5 (F) of Ordinance #05-102 in its entirety to read as follows:

**SECTION 5 – SPECIFIC PROVISIONS ON ROADS/TRAFFIC CONTROL**

- F. The provisions of Section ss. 346.57, 346.58, and 346.59, Wis. Stats., relating to the maximum and minimum speed of vehicles, are adopted as part of this Ordinance as if fully set forth herein, except as specified pursuant to Section 349.11 (3) ©, Wis. Stats., the following highways have speed limits that have been modified by the Town Board under 349.11 Wis Stats as follows:


