TOWN OF RICE LAKE
APPLICATION FOR DRIVEWAY PERMIT

In accordance with Section 4-4-1(c)(1-2) and Section 4-4-1(d)(1-4) of Ordinance No. 00-103 entitled "Ordinance Regulating Road Excavations, Providing for the Removal of Obstructions From Public Highways and for the Installation of Culverts" the undersigned applicant does hereby request permission from the Town of Rice Lake for a driveway to be installed at the following described property (give full legal description in addition to house and street numbers if known):

The undersigned applicant states that:

- (1) The applicant represents all parties in interest, and that such proposed driveway is for the bona fide purpose of securing access to his property and not for the purpose of parking or servicing vehicles, advertising, storage or merchandising of goods within the dedicated portion of the Town road or street, or for any other purpose.
- (2) The Town, notwithstanding the construction of such driveway, reserves the right to make any changes, additions, repairs or relocations within the dedicated portion of the Town road or street at any time, including relocation, reconstruction, widening and maintaining the street without compensating the owner of such private driveway for the damage or destruction of such private roadway.
- (3) The permittee, his successors or assigns, agrees to indemnify and hold harmless the Town of Rice Lake, its officials, officers, agents or employees, against any claim or any cause of action for personal injury or property damage sustained by reason of the exercise of such permit.
- (4) The Town does not assume any responsibility for the removal or clearance of snow, ice or sleet or the opening of any windrows of such material upon such portion of such driveway within the dedicated portion of the town road or street.

In addition, by submission of this signed application the undersigned applicant acknowledges receipt of a copy of Ordinance No. 04-101 adopted February 10, 2004 and Chapter 4 of Ordinance No. 00-103 adopted May 8, 2000 which specifies the requirements for driveway and culvert location, design and construction and does hereby agree to comply with such requirements. All costs of construction of the driveway and inspection thereof shall be paid by the applicant.

Design specifications and a drawing depicting the location and orientation of the proposed culvert in relationship to the real estate involved and the adjacent road, street, or highway must be submitted with this application.
