**TOWN OF RICE LAKE  
SPECIAL HAULING TERMS AND CONIDITIONS**

1. This permit must be available for inspection by any law enforcement officer or any authorized agent of the Town of Rice Lake and must be carried in the vehicle when the haul is being made. The permit is invalid if it is not presented when requested.
2. This permit is good **only** for the stipulated information stated on the permit.
3. This permit is not valid for use on State or County Trunk Highways, City or Village streets and roads. This permit is not valid outside of the Town of Rice Lake.
4. Any violation of the terms of this permit or the conditions stated above will be cause for immediate revocation of the permit. Revocation will take place by the holder or vehicle operator being informed in writing or verbally that the permit has been withdrawn.
5. Prior to this permit being authorized, a refundable performance bond is required to be submitted in the amount of \$\_\_\_\_\_ payable to the Town of Rice Lake. This bond will be refunded after a period of \_\_\_\_\_ from the expiration date of this permit, provided no damage has occurred to town roads as a result of this special hauling permit.
6. Violation of the terms or conditions of this permit will result in a minimum of 1 year's suspension of any special hauling permits.
7. Special hauling permits are granted on a case by case basis and the Town of Rice Lake has no obligation written or implied to grant such permits. The granting of permits will be at the sole discretion of the Town Chairman, or his designee.
