- A plan of the proposed alteration, extension or addition, showing its location and details of construction, including specified depth, method of excavation, open out or augering, provisions of restoration and whatever the Town would deem necessary for review and consideration. In being issued a permit the utility or contractor agrees to be bound by the regulations of this permit.
- A fee of Forty-Five Dollars (\$45.00) payable to the Town of Rice Lake.

In addition, by submission of this signed application the undersigned applicant agrees to:

- indemnify and save harmless the Town of Rice Lake and its officers from all liability for accidents and damage caused by any of the work covered by this permit.
- Receipt of a copy of Section 4, Chapter 3, of Ordinance No. 00-103 entitled "Ordinance Regulating Road Excavations, Providing for the Removal of Obstructions From Public Highways and for the Installation of Culverts" and Ordinance No. 04-101 "Amendment to Ordinance #00-103" which specifies the requirements for such permit.
