TOWN OF RICE LAKE BID SPECIFICATIONS FOR NEW HEATING SYSTEM IN MUNICIPAL BUILDING LOCATION: 1830 MACAULEY AVE., RICE LAKE, WI 54868

The existing unit heaters and horizontal furnace are to be removed. The supply duct systems are to be removed and patched, and unused roof vent penetrations must be sealed. Two new 150,000 BTU infrared tube heaters are to be installed in the shop area per attached drawing. Gas piping, control wiring, and power wiring to be included. The existing 100-amp main breaker panel on the west wall is to be upgraded to a new 100-amp, 32-space panel, and new wiring to be extended to electric heat installed as follows: one new 4' baseboard in the women's bathroom, one new 2' baseboard in the men's bathroom, and two new 8' baseboards in the break room (locations for each as shown on attached drawing). Each room is to have a new thermostat control.

The exiting exhaust fans in the bathrooms will remain. Plans are to be prepared and submitted for State approval. State fees are to be paid by the township. Additional work required by State plan review (if any) is to be included in bid price.

Bid price to include all materials and labor to provide a complete and operating system.

Bid should also include prices for the following options:

Option 1: A high volume exhaust fan is to be installed on the north wall near the ceiling to ventilate the shop area. A "Tox Alert" carbon monoxide control is to be installed to activate the fan.

Option 2: In lieu of the electric baseboard heaters, a small electric furnace is to be installed on the mezzanine adjacent to the air compressor, and connected to the existing supply ducts. A return air filter grille is to be installed in the break room, and a fresh air intake is to be installed for ventilation.
