NOTICE IS HEREBY GIVEN to the electors of the Town of Rice Lake that a Town Caucus will be held at the Rice Lake Town Hall, 1830 Macauley Ave., Rice Lake, on Monday, January 14, 2019 at 6:45 p.m for the purpose nominating candidates for two-year terms for the positions of Chairperson (Incumbent Thomas Fankhauser), Supervisor I (Incumbent Robert Slagstad) and Supervisor II (Incumbent Mark Kucko). These positions will be voted upon at the spring election to be held April 2, 2019. All interested parties are invited to attend. This building is handicap accessible. Any person that has a qualifying disability, as defined by the Americans With Disabilities Act, that requires the meeting or materials at the meeting to be in an accessible location or format, must contact the town clerk at the Rice Lake Town Hall, 1830 Macauley Ave., Rice Lake, 715-234-8087, at least 24 hours prior to the commencement of the meeting so that any necessary arrangements can be made to accommodate each request.

1. Call meeting to order by Chairman Fankhauser (Presiding Official).
2. Chairman Fankhauser calls for an election of a Presiding Official by the electors. Nominations for Presiding Official will be done by acclamation (Chairman Fankhauser is unable to preside caucus as the office of chairman will be on the ballot this year.)
3. Electors select two tellers to count votes if needed.
4. Nominations: (Presiding Official will open and close nominations for one office at a time. Names of candidates will be placed in nomination by motion made and seconded from the floor. If more than two nominations are made for one office, a ballot vote will be taken. The two candidates receiving the most votes shall be nominated.)
 - a). Chairperson (Incumbent – Thomas Fankhauser)
 - Presiding Official requests nominations for the office of Chairperson.
 - After nominations are made and seconded, the Presiding Official shall ask two more times “Are there any more nominations for Chairperson?”
 - After hearing none, Presiding Official announces that “Nominations are closed for the office of Chairperson”
 - b). Supervisor I (Incumbent – Robert Slagstad)
 - Presiding Official requests nominations for the office of Supervisor I.
 - After nominations are made and seconded, the Presiding Official shall ask two more times “Are there any more nominations for Supervisor I?”
 - After hearing none, Presiding Official announces that “Nominations are closed for the office of Supervisor I”
 - c). Supervisor II (Incumbent – Mark Kucko)
 - Presiding Official requests nominations for the office of Supervisor II.
 - After nominations are made and seconded, the Presiding Official shall ask two more times “Are there any more nominations for Supervisor II?”
 - After hearing none, Presiding Official announces that “Nominations are closed for the office of Supervisor II”
5. Consideration of Adjourning the Town of Rice Lake Caucus.
