

TAX PAYMENT DUE DATES & DETAILS

1ST INSTALLMENTS - Due by January 31, 2020, payable to the Town of Rice Lake, & may be remitted as follows:

1. **BY MAIL** - send to the Town of Rice Lake, 1830 Macauley Avenue, Rice Lake, WI 54868. Receipts will not be mailed unless a **SELF-ADDRESSED STAMPED ENVELOPE** is provided!
2. **IN PERSON** – at the Town Hall on Tuesdays thru Fridays between 8:00 am and 12:00 pm
3. **DROP BOX** - deposit payment anytime in drop box at the Town Hall. Receipts will not be mailed unless a **SELF-ADDRESSED STAMPED ENVELOPE** is provided!
4. **ONLINE OR BY PHONE** - log on to townofricelake.com and click on Government, then Tax Payment Information or by Phone call 877-798-2040 - **SERVICE FEES WILL APPLY AS FOLLOWS:**
 - Credit Card - 2.39% of the payment amount
 - VISA Debit Card - Fixed rate fee of \$3.95
 - ACH Direct Debit from a checking or savings account - Fixed rate fee of \$1.50

Please note, the Town of Rice Lake does not refund overpayments that are less than \$2.

2ND INSTALLMENTS – Due by July 31, 2020, payable to the Barron County Treasurer at 335 E. Monroe Avenue, Room 2412, Barron, WI 54812. Payment options are listed on the County’s website at www.barroncountywi.gov

DOG LICENSES MUST BE OBTAINED ANNUALLY BY MARCH 31 FROM THE TOWN OF RICE LAKE:
Simply remit, either in person, by mail, or in the Town’s drop box, a copy of your dog’s current **RABIES VACCINATION CERTIFICATE** (not the tag) along with the applicable fee: \$6.00 for spayed/neutered or \$11.00 for unaltered. A **\$6.00 late fee** will apply for applications submitted after March 31. **FAILURE TO LICENSE YOUR DOG COULD RESULT IN A FINE FROM BARRON COUNTY SHERIFF’S DEPT. OF UP TO \$500!**
